

From the President

The 2022-2023 athletics season saw the return of many of our junior athletes and the start for many other athletes and families. We waved goodbye to the previous seasons' disruptions by the COVID-19 pandemic but were welcomed by mother nature who washed out a couple of the early rounds, and made it hard for the Diamond Valley program coordinator to schedule, with rain affecting a number of the initial rounds.

This season saw the return to all the championship events. Our Rosanna athletes were able to participate in the Diamond Valley Relay Championships and Centre Championships, as well as the U9-16 athletes having the opportunity to compete in the LAVic State Combined Championship, the North Metro Region Relay Championships, LAVic State Relay Championships, North Metro Region Track and Field Championships, which then qualified athletes for the LAVic State Championships.

We had 8 of our athletes compete at the NMR region relays, with 4 qualifying for the State relay event. Alicia Sheehy was a part of the U12 girls DV team bringing home a State Bronze medal. Well done Alicia!

We also had 14 athletes compete at NMR Track and Field, with 5 of our girls qualifying to compete in 14 events at the State event, with an amazing nine top ten placings – well done Team Rosanna!

There were a few changes to the athletics program at the Diamond Valley centre, with the introduction of timed/measured events for our Under 6 on-trackers, as well as the turbo javelin for our Under 9-10 athletes. This allowed for some inaugural Rosanna club records. Well done to our athletes who have set the bar for others to follow in these events! In addition, we had a further 6 club records broken throughout the season – a stellar effort!

However, competing at little athletics is not all about the medals and the placings, even though these are exciting! It is about attending training regularly, showing up each week to compete in all the events on offer, doing your best and most importantly having fun. There were a core group of athletes that turned up each and every week, rain, hail or shine; and they competed in every event on offer for their age group, giving everything a go and smiling and having fun whilst doing it. This is the spirit we want to promote at Rosanna.

From my view at the tent each week I can honestly say that I believe all of our athletes have a great experience each week.

We have created a great community feel down at our end of the track, filling the area with a sea of smiling purple people, and plenty of loud voices yelling "Go Rosanna!" to encourage our athletes on the track.

With our On Trackers Board and prizes to promote inclusion of our youngest members, and Rosanna Roo helping our athletes feel brave to just have a go, we show each week that we have great team spirit and support for each other.

There are always plenty of smiles and laughter, many new friends made, and the ever-present opportunity to 'do your best' in the form of our Personal Best (PB) Challenge. With the return to a relatively uninterrupted season, we saw the PB competition heat up, and reach highs that we haven't seen for a number of years.

There were many athletes achieving the 10 PB ribbon and obligatory pose for a social media photo, as well as the 15 PB ice-cream voucher, and a further 25% of our athletes got to the 20 PB milestone and earned themselves a Rebel Sport voucher! This year even saw the return of a select few athletes achieving the 25 PB ribbon and a surprise voucher to relax at the movies in the off-season.

In total our athletes achieved **750 PBs** for the season – a sensational effort and one we hope will keep growing each season to come.

The challenge to better yourself each week is the spirit we want to encourage at Rosanna. To focus on personal improvements, and to be able to celebrate those with our Team is beneficial to each and every athlete, no matter their ability.

Lastly, our athletes wouldn't be able to enjoy the competition each week without the help and support of our Rosanna Committee (Crew) and our families.

I would like to thank the 2022-23 Crew members for their continued support and dedication to ensure that our events are set-up and manned each week, and the general club operations are managed well.

Thank you to: Duncan Palmer (Secretary and PB Coordinator), Monty Kirsz (Treasurer), Rachel Lohoar (Registrar) who stepped up from the assistant role after an early season resignation from our Registrar, Shaun Lohoar (Team Manager), Kate Roy-Chowdhary (Uniforms), Greg Gannon, Luong Dao (General Committee), and Jason Watts (General Committee, Shot Put Chief and Graphic Design Guru).

Finances at a glance

The format of our financial reports will appear different this year as we have moved across to the Xero online. We have been using Xero accounting software for two years now, so there will be consistency in the numbers for this and last year.

With COVID restrictions out of the way, the year started with a decent amount of rain, providing delays in events and registrations. Withstanding this, athlete numbers were consistent, with 63 signing up, only down two on last season. A number signed on very late in the year, and we expect another strong year ahead from discussions with other sporting clubs and schools.

We recorded a loss of \$2,890.61 in 2023. This was in part due to a reduction in the club fee component paid to us from Diamond Valley LAC, but was also due to larger purchases of uniform stock, assets and part payment of last year's AGM occurring this year. Uniform sales were also down 29%. Other than constant purchases, our main expenses are trophies, athlete awards and AGM costs which have been consistent in the last few years (other than a timing difference in the AGM payment).

Towards the end of the previous season, we carried out a Bunning's sausage sizzle and raised \$1,817.45. We recorded a profit on the day of \$1,230.15, an increase of 14% on the previous year. This event is a must for the club; another one is lined up in the coming month.

We successfully applied for a local government grant of \$1,500 for a new tent during the year. As a goodwill gesture, we purchased and donated the new tent for Diamond Valley at the cost of \$2,075.

We are in a very good financial position with a combined bank balance at the end of the season of \$12,644.35.

Considering the larger-than-normal expenditure and slightly reduced registrations and sales, it was a good year for the club.

Always great to see new faces and plenty of smiles and cheering during the year, and we look forward to your continued support in the season ahead.

Auditors Report



Rosanna Little Athletics Club For the year ended 31 March 2023

We have audited the accompanying financial report, being a special purpose financial report, of Rosanna Little Athletics Club, which comprises the balance sheet as at 31 March 2023, and the profit and loss for the year then ended, a summary of significant accounting policies, other explanatory notes and the directors' declaration.

1. The Responsibility of the Directors for the Financial Report

The directors of the company are responsible for the preparation and fair presentation of the financial report and have determined that the accounting policies described in Note 1 to the financial statements, which form part of the financial report are appropriate to meet the financial reporting requirements of the company's constitution and are appropriate to meet the needs of the members. The directors' responsibilities also includes designing, implementing and maintaining internal control relevant to the preparation and fair presentation of the financial report that is free from material misstatement, whether due to fraud or error; selecting and applying appropriate accounting policies; and making accounting estimates that are reasonable in the circumstances.

These Auditing Standards require that we comply with relevant ethical requirements relating to audit engagements and plan and perform the audit to obtain reasonable assurance whether the financial report is free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial report. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial report, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the financial report in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made, as well as evaluating the overall presentation of the financial report.

The financial report has been prepared for distribution to members for the purpose of fulfilling the directors' financial reporting under the company's constitution. We disclaim any assumption of responsibility for any reliance on this report or on the financial report to which it relates to any person other than the members, or for any purpose other than that for which it was prepared.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

3. Independence

In conducting our audit, we have complied with the independence requirements of the Australian professional ethical pronouncements.

4. Auditor's Opinion

In our opinion, the financial report presents fairly, in all material respects the financial position of Rosanna Little Athletics Club as at 31 March 2023 and of its financial performance for the year then ended in accordance with the accounting policies described in Note 1 to the financial statements.

Registrars Report 2022/2023


Hi RLAC family,


What a fantastic end to another great season! This season we didn't have to worry about any covid restrictions. Instead, we had constant rain early in the season that kept us away from the track. Then torrential rains and flooding saw our field events disrupted, not to mention the uprooted trees across our end of the carpark!

Despite these early setbacks, we had a similar number of athletes to the previous year competing with 63 athletes in total. This was made up of 23 new members (11F & 12M) and 40 returning members (22F and 18 M).

Our 63 athletes were spread across 42 families, with the following numbers

- 1 child registered 26 families
- 2 children registered 12 families
- 3 children registered 3 families
- 4 children registered 1 family
